I understand that I have been granted use of the Live Oak Preserve Clubhouse on the above stated date and time, subject to the following terms and conditions.

- 1. **This is a Private Event and it is NOT open to the Public.** Resident agrees to provide a copy of the invitation to the event and a List of Invitees at least 24 hours before the event.
- 2. Live Oak Preserve Association Inc. (the "Association"), its agents, employees, members, Board of Directors, Officers, and Greenacre Properties, Inc., and their representatives collectively ("Agents") will in no way be liable for loss, damages, or injuries to any resident or guest in connection with this event. Resident shall indemnify the Association and Agents and hold them harmless from any and all claims which relate or refer in whole or in part to the Resident's use of the Clubhouse or activities which relate, refer or arise out of such use, in whole or in part, even if such claim arises out of the Association or Agents gross negligence.
- 3. Resident assumes full responsibility for any loss or damages caused to the premises and property of the Association, or the person or property of any other resident or guest, as a result of the use of the clubhouse or surrounding areas.
- 4. Resident agrees to return the premises in the same condition it was received and is responsible for removing and disposing of all trash and garbage created as a result of this activity.
- 5. Resident agrees to be fully responsible for maintaining an orderly function and will allow no illegal activity on the premises will comply with all governmental laws, rules, regulations and ordinances and will refrain from loud and annoying activities that may disturb surrounding residents or other clubhouse guests.
- 6. Resident agrees and understands that the use of this facility is granted for residents only and may not be reserved for a non- resident of Live Oak. The resident must also be present for the entire duration of the function.
- 7. Reserved area consists of main clubhouse and kitchen area only. The Pool is not part of the

- 9. Available rental hours are from 10:00 a.m. to 9:00 p.m.
- Ten (10) day minimum advance reservation requested for reservation of the clubhouse.
 Deposit and fee checks must accompany the reservation form. All checks will be cashed upon receipt.
- 11. Parking is limited. If a large number of guests are expected, resident may be required to obtain professional assistance for guest parking. Parking on the grass and in front of homeowners' residences is strictly prohibited.
- 12. Resident will be required to notify all guests of the policies and procedures for entrance into the community and will need to make arrangements to allow entry to the community on the date of the event.
- 13. Resident agrees and understands that an adult MUST supervise all functions, (including functions at which minors are present).
- 14. In all instances, the Association resident who reserved the clubhouse must be present at all times while the clubhouse is in use under this Agreement.

- 14. COST TO RENT THE FACILITY: \$200 for 0-50 people. NONREFUNDABLE Fee covers 5 hours. Any set-up and clean-up time is included in the 5 hours, so plan accordingly. **You will not be permitted to set-up until your reservation time begins**. There will be a fee of \$25 for each additional reserved hour.
- 15. Management / clubhouse staff will not provide set up.
- 16. The use of propane, charcoal, or other barbecue grills is prohibited in the clubhouse, patio, or pool deck area.
- 17. If using a caterer, you must obtain a certificate of insurance from the caterer which lists the Association as an additional insured. All food and provisions must be removed at the end of the function. All trash MUST be removed and disposed of by the caterer or resident and not left at the clubhouse, kitchen, or surrounding trash cans. Dumpster in parking lot may be used for trash.
- 18. The Swimming Pool, Fitness Center and Billiard Room are not part of the clubhouse reserved for private party consideration. These parts of the building must remain open for other residents' use.
- 19. No decorations are to be tacked or nailed into any wall or ceiling surfaces.
- 20. There is **NO ALCOHOL** permitted in or around the clubhouse.
- 21. The area is monitored by cameras.
- 22. No furniture is to be moved in clubhouse.
- 23. The clubhouse may not be reserved more than 60 days in advance.
- 24. Table cloths are required on dining tables.
